The constituted screening committee has scrutinized the applications of the below teaching and non-teaching positions and submitted their report. As directed by DoP, the recruitment of two Professors and one Associate Professor is kept on hold. The institute has completed the process of recruiting one "Professor" and one "Assistant Professor" in the Department of Pharmaceutics.No suitable candidates were found for the post of Assistant Professor in Pharmaceutical Analysis (02 positions) and Regulatory Toxicology (01 position). Hence, the institute will re-advertise the same in the next phase.The institute is in process of recruiting 08 Posts, except NT-05, NT-06, NT-07, and NT-10 as mentioned below due to the receipt of insufficient eligible applications. Further, as per directions of the Department, the NT-01 (Registrar) will be filled through centralized recruitment.

The above status on the 3rd phase of teaching and non-teaching recruitment of NIPER Hajipur is placed for the approval of the BoG. Further, it was approved in the 12th Meeting of the BoG to proceed with the approved selection panel. One of the Director's nominees showed his inability to attend the scheduled meeting on 15-16th December 2022, accordingly, the Chairman of the Board approved the substitute of the Director's Nominee.

Resolution: Approved, Further board recommends for a request to Department of Pharmaceuticals seeking permission to fill up all the sanctioned posts on direct recruitment basis giving a proper justification.

Agenda No.17 (ii): Approval of additional positions to besanctioned for teaching and non-teaching.

Earlier, 19 teaching and 25 non-teaching positions for 3 departments were sanctioned vide office order – F.No.50013/1/2018-NIPER dated 4th February 2019.

Jurrently, the institute has increased the number of departments to 6 and planning to have one more department in AY 2023-24. Student strength will also increase from 54 to 140 accordingly as per the vision target.

In this connection, additional posts in teaching and non-teaching may be sanctioned by the Department as similar to other NIPERs with seven disciplines vide D.O. Letter No. 50013/1/201/-NIPER dated 4th February 2019 and dated 18th November 2020.

Hence, the Board is requested to approve the additional Teaching and non-teaching posts like other NIPERs with seven disciplines in order to meet the academic requirements of the Institute.

Resolution: The Board recommends the requirement of additional Teaching and Non-Teaching positions be sent to the Department of Pharmaceuticals considering an increase in the number of departments as well as the students' intake as per the vision and targets.

Agenda No.17 (iii): Approval of one 25–30-seater AC bus with an estimated cost of Rs 30 lakhs to meet academic and research requirements.

One 25-30-seater AC bus with an estimated cost of **Rs 30 lakhs** to be procured through **Government-e-Marketplace (GeM)**. Further, an emergency care unit with a well-equipped-ambulance, regular medical and paramedical staff to be created in the campus. Temporarily, the institute may look for such facility on contractual basis until entire set-up is established that includes procurement of vehicle and recruitment of drivers dedicated to such 24 hours service. *Resolution:* Approved.
