At the outset, the Director, NIPER Hajipur welcomed and appreciated all the members for sparing their valuable time out of their busy schedule. There after agenda items were taken up for discussion by the Registrar:

**Item No. 01/9<sup>th</sup> LSBWC/2023: Confirmation of ATR on 7<sup>th</sup> Meeting of the Laboratory Services, Building and Works Committee held on 20.04.2023 and 8<sup>th</sup> Meeting of LSBWC through circulation mode.**

**Resolution:** The Registrar briefed the Members about Action Taken by the Institute on resolutions made in last meetings. The Action Taken Report was **considered** and **7<sup>th</sup> Meeting of the LSBWC held on 20.04.2023 and 8<sup>th</sup> Meeting of LSBWC** were **confirmed**.

**Item No. 02/9<sup>th</sup> LSBWC/2023: Director apprises the committee about the progress of the institute.**

**Resolution:** After details discussions and inputs offered by the members with regards to slow progress, the Chief Engineer, CPWD (being member of Committee) were asked to expedite the matter so that purpose of the Institute may not be defeated.

**Item No. 03/9<sup>th</sup> LSBWC/2023: Administrative Approval and Expenditure Sanction on revised Preliminary estimate for Extension of Girl's Hostel and other requirements upto (G+4) storey at NIPER-Hajipur.**

**Resolution:** *The Chairman briefed about the requirement for changes/modification in initial proposal has been made on the basis of space constrain and The complete block may be renamed as “Girls Hostel” in place of International Hostel & Guest House and Girls Hostel block. During discussion the Chief Engineer, CPWD has suggested that “One block of Girls Hostel may be constructed upto G+4, however another block may constructed based on the balance sanctioned amount for the purpose”.*

*All the members appreciated the suggestion made by the Chief Engineer, CPWD agreed with his suggestions and resolved to approve the same subject to statutory approvals. However, one of the members has submitted the remarks attached in Annexure.*
