## The committee is required to oversee as per the Clause 3.5.2 of the NIPER Statute detailed below:

- a. to approve all major capital works after securing the necessary administrative approval from Board of Governors and expenditure sanction;
- b. to give the necessary administrative approval and expenditure sanction for minor works and works pertaining to maintenance and repairs / renovations within the grants placed at of the Institute for the purpose beyond the value of Rs 2.00 lacs;
- c. to record the estimates of cost of buildings and other capital works, minor works, repair and renovations and the maintenance and the like;
- d. to make technical scrutiny as may be considered necessary by it; to enlist the suitable contractors and accept the tenders and provide directions to departmental works where necessary;



- e. to fix the rates not covered by the tender and settle claims and disputes with contractor;
- f. to perform such other functions in the matter of construction of buildings and development of the land for the Institute as the Board may entrust to it from time to time;
- g. to devolve system for maintenance of laboratory services of the institute The order is issue on approval of the competent authority.
