- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

4. Service & Support

The Service Provider must own 30% of the bid quantity of vehicles in Service Provider's name or in the name of the proprietor / partner of the Service Provider. Necessary documents relating to proof of ownership will be uploaded by the bidder for verification of the buyer. Such Service Provider owned vehicles will be part of the fleet to be deployed by the Service Provider in case he gets the contract against this bid.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Terms and Conditions

- a. The contract would be valid for one year fr om the date of contract and can be extended fo r further two years, one year at a time, on the b asis of requirement, performance and at the sol e discretion of NIPER- HAJIPUR.
- b. The vehicle provided must be registered in Bihar and properly insured.
 - c. The Driver must have the licenses and prop erly dressed up with Khaki or white Shirt & trou sers during the duty hours.
- d. The Agencies will be solely responsible for any misconduct of the drivers.
- e. No advance payment would be made.
- f. TDS will be deducted at source from hiring bill/s as per the Income Tax Act.
 - g. NIPER- HAJIPUR reserves the right to termin ate the contract with 15 days' notice without as signing any reason.
 - h. In case of any Loss, damage or accident, total responsibility lies with agency/firm and driver will be fully responsible in case unauthori zed / illegal materials are found in the vehicle during the use of the of ficials of the NIPER- HAJIPUR.
- i. Rentals will be revised during the contract period in the following manner:-
 - Whenever increase or decrease in price of diesel/petrol touches 10% of the previous price,
 - per kilometer rate would corr espondingly be increased or de creased by 5%, and
 - 2. Fixed monthly rental (for mon thly hired vehicles) will corresp ondingly be increased or decre ased by 3%.
 - The beginning price of petrol/diesel will b e the price prevalent in Bihar on the day of the agreement.
 - For all subsequent revisions, the previous price will be the price at which the previous us revision has taken place.
- j. Parking & toll taxes will be paid by the contractor.
- k. Vehicle model hired on monthly basis should not be of earlier than Jan 2024.
 - I. The vehicle(s) should be in good condition and should be provide d on time. Replacement of vehicle shall be done immediately in case of repair, maintenance or any other condition with equally good condition vehicle. The service provider shall be responsible for appropriate

insurance coverage. In this regard, the service provider shall maintain workers compensation; provider shall also maintain comprehensive g eneral liability insurance, including contractual liability coverage adeq uate to cover the indemnity of obligation against all damage to any pr operty arising out of, or in connection with, the services which result f rom the fault of the service provider, or its staff/driver. The service pr ovider shall provide NIPER- Hajipur with certification thereof upon req uest.

- m. The service provider/contractor should hav e enough resources to repair their vehicles in m inimum possible time. When required, they sho uld be in a position to substitute/replace or arra nge extra vehicle at very short notice.
- n. The service provider/agency shall not provide any person as driver who has not completed 18 years of age. The agency shall comply with all statutory provisions as laid down under various Labour Laws like Minimum wages, Contract Labor Act etc. In case of violation of any such statutory provisions, the agency will be solely responsible. For Any Incidents the Selected Agency Only will be responsible.
 - 2. Additional Terms and Condition for Monthly Hi red Vehicle: In addition to terms and conditions mentio ned above in part 1, the following additional terms and c onditions shall be applicable on vehicles taken on month ly hire:-
- a. The driver should have at least 3 years of work experience.
 - b. The driver shall be in proper dress khaki o r white shirt- trouser or safari suit. Behavior of t he driver should be extremely courteous and re fined. He should be well aware of and should m eticulously follow traffic rules. He should not be in habit of rash and fast driving and should have proper vision. He should have absolutely clean background and police record. A self-declaration certificate shall be furnished by the selected vendor/agency.
 - c. Driver shall be provided with mobile phone for smooth communication and the cost shall be borne by agency
 - d. Minimum monthly emoluments paid to the driver would be as per Minimum Wages Act. Ho wever, the agency is free to pay any amount ab ove this minimum stipulation. Further, the agen cy would also be required to adhere to all gover nment statutory requirements in respect of min imum pay and statutory deductions.
 - e. They duty timing of the monthly hired driver would be normally from 8 am to 8 p m but could be longer as per requirement

and need. Accordingly, the driver needs to be paid/compensated for overtime and other allowances by the agency.

- f. One day compulsory rest in a week shall be given to the driver. On the day of rest, alternate driver shall be provided by the agency/ser vice provider as per the need of NIPER- HAJIPUR.
 - g. The agency will have to provide the replace ment of driver in case of any eventuality. NIPER HAJIPUR has the right to ask the agency for re moval of any Driver who is not found competen t or disciplined.
- n. Once assigned, the vehicle will not be changed/replaced without prior permission of NIPER- HAJIPUR.
- i. There will be separate log book for monthly vehicle maintained by the driver/agency. All entries in the log book will verified/countersig ned by the concerned officers.
- j. In case of failure to provide vehicle on time, NIPER- HAJIPUR will p rocure a vehicle from open market and the charges paid to such vehicle will be deducted from the monthly bill of the service provider. In a ddition, a penalty of Rs. 1000/- per day till the date of default shall als o be charged by NIPER- HAJIPUR from the service provider, which will be deducted from the bill.
- k. The service provider/firm shall submit attested copies of owner b ook, insurance papers and other papers of the vehicle and attested c opies of driver license.
- 1. The vehicle must have the commercial registration.
- m. The hired vehicle will also be available during Saturday/Sunday/H oliday.
- n. One vehicle (2000km x 320Hrs) of 07-seaters will be on day time and another one vehicle (500km x 360Hrs) of 05-seater will be on night time.
