8. The Deputation is for 02 years, extendable as per GoI norms and at the discretion of the institute's competent authority. (Pay II) dated 17th June 2010, and the Government of India's instructions issued from time to time on the subject. The deputation period may be extended for a further year based on performance / institutional requirements.
